DAMAGE RESPONSIBILITY

The Primary Renter is fully responsible for any damage, loss, or theft of the vessel or equipment during the rental period, regardless of fault, as outlined in the Rental Agreement.

This Damage Schedule provides standard pricing for common damage items. All charges will be determined based on inspection, documentation, and assessment by Crab Island Watersports LLC. This list is not all-inclusive. Any damage not listed will be charged based on repair or replacement cost.

INSPECTION & CHARGES

All vessels will be inspected upon return. Determination of damage, condition, and applicable charges shall be made solely by Crab Island Watersports LLC based on inspection, photographs, video, and other documentation. Any damage, excessive wear, or missing equipment will be charged to the card on file in accordance with the Rental Agreement.

Excessive cleaning may result in a cleaning fee of up to \$150.00. A damage processing fee of up to 20% may be applied to cover inspection, documentation, and administrative costs.

DOWNTIME / LOSS OF USE

In addition to repair or replacement costs, a downtime fee will be charged at the current full daily rental rate for each day the vessel is out of service.
